**Creator Sketch:**

Robert Young Eckels, Jr. (Bob) was born in Temple, Texas, July 24, 1929, to Robert Young and Mildred Daniel Eckels. Eckels was a graduate of Houston Independent School District and went on to receive his bachelor's degree from Sam Houston State College and his master's degree from the University of Houston. He served two years in the United States Army from 1952 – 1954 and in the Army Reserve until honorably discharged June 30, 1960.

Eckels began his career as a public school teacher and businessman. In 1960 he was elected to the Houston Independent School District school board. President for four of his nine years on the board, he is credited with aiding in the non-violent integration of Houston schools while other schools throughout the country were erupting into violence.

Eckels ran for Harris County commissioner in 1968 as a Democrat and lost the race in the midst of accusations that he pressured teachers to vote for him. In 1972, as a Republican, Eckels once again campaigned for county commissioner and defeated the incumbent William F. "Bill" Elliott. In 1980 the Federal Government indicted Eckels and a television reporter for mail fraud in soliciting \$46,680 for the production of a 1976 educational film on county government, *Houston and Then Some*. Both were acquitted.

In February 1986, Eckels was indicted for allegedly stealing county bridge timbers, using county employees to deliver the wood to his Sealy farm, and accepting an illegal gift. A mistrial was declared after a juror brought a law dictionary into the jury room.

Eckels's trial for accepting one mile of paved road from G & S Asphalt Company on his Austin County ranch began November 2, 1987. After almost a month of testimony, a jury convicted Eckels of official misconduct. A contentious battle ensued between Eckels and the District Attorney, Johnny Holmes, on whether he was automatically removed from office with the jury's decision. After a month of legal wrangling, Eckels accepted a plea agreement. He resigned as Harris County Commissioner Precinct 3 on January 5, 1988, paid a \$2000 fine, and agreed not to appeal. On January 12, 1988, the Harris County Commissioners Court appointed Elizabeth Lyons Ghrist to replace Eckels with the proviso that Ghrist not seek election to the office.

Eckels's legal problems did not end with his resignation from office. In August 1988 Eckels was fined \$2,000 after pleading no contest to felony wiretapping of employee telephones. The charges were subsequently reduced to misdemeanor charges.

Eckels died of an apparent heart attack at his ranch on December 24, 1989. His second wife, Mary Francis, and two children, Robert A. Eckles (Harris County Judge 1995 – 2007) and Carol Ann Adams, survived him.

Photoprints reveal a pictorial history of the political activities, daily responsibilities, interests, and involvement of Bob Eckels, his staff, and constituents in Precinct 3. Local political figures are often represented in those photographs documenting his annual community picnic. Early photographs of his family and the young Robert A. Eckels (later to become a state legislator and county judge) are of interest. Many of the photographs, negatives, and contact sheets are unidentified.

**Subseries:** Audio Video Tapes

**Range of Dates:** 1977 – 1986, n.d.

Forty-one audio video tapes documented Bob Eckels’s tenure as a Harris County commissioner. Eighty nine per cent of the tapes were in ¾ inch U-matic formats and could not be appraised until a 2016 digitization project. At that time it was determined five of the tapes were either blank or unplayable. Of the remaining 37 tapes, 25 are of poor quality with either audio or visual distortion or both.

A complete listing of the digitized tapes, their content and condition is available from the archives. The general subjects of the tapes are indicated in the title, with most of them created by Broadcast News Report, a private “clipping” service for video. Please contact the archivist for complete information on individual titles.

**Dates: Dates** 1935, 1978-1988

**Scope and Contents Note:**

Newspaper clippings, programs, invitations, correspondence, photographs, and ephemera document Harris County and the personal interests of Commissioner Bob Eckels.

Among the subjects covered include Harris County Precinct 3 programs, flood control, bridge and road improvements, toll road bond issues, and county elections. Of special interest is a scrapbook that contains newspaper clippings of the 1935 flood in Houston.

Donated by an unknown creator, three scrapbooks document the years 1985 – 1987 in particular the political indictments against Eckels.
