

Assessor and Collector of Taxes – Tax Records

A program of microfilming combined with years of neglect of the paper records resulted in a low survival rate for hard copy tax records in Harris County. All surviving records created prior to 1940 have been accessioned for their artifactual value in addition to their informational value.
